From the second application onward, approval must be reconfirmed by all original degree examination committee members or by the departmental (or institute) affairs meeting of the applicant's original academic unit.
- If the thesis or dissertation has been submitted to the NCL, the university should send an official letter with the signed application form and certification documents to apply for embargo.
- The school will not be held responsible if the contents of the applicant's dissertation are leaked before the public viewing period due to reasons not caused by the school.
